Waiver / Safety Agreement and Terms and Conditions

RECREATIONAL SKIING AND SNOWBOARDING

1. All users must be fully aware that skiing, snowboarding and all associated activities contain inherent risks and dangers, including serious injury or death. All users must know, understand and accept the scope, nature, and extent of the risks involved in the activities. All users must willingly accept any and all such risks and dangers.
2. Everyone Active accepts no liability for any personal injury to, loss or damage to any individual's personal effects whilst they are on Everyone Active (Silksworth Sports Complex) premises except where the injury is caused as a result of our proven negligence.
3. All persons using the main slope must be in control of their speed and direction at all times and be able to use the lifts/tows unaided. This means the ability to perform a minimum standard of snowplough turns when skiing and linked slide turns when snowboarding.
4. Any person below this level will only be allowed on any part of the slopes under the instruction of a Sunderland Snowsports Centre instructor. Use of the nursery slope is for beginners only, who have booked and paid for tuition by Sunderland Snowsports Centre instructors.
5. Long sleeves, trousers and gloves, as a minimum must be worn at all times when on the slopes. You may wish to consider wearing a helmet.
6. Children under the age of 8 years must be accompanied by an adult to recreational ski or snowboard. The accompanying adult must sign the disclaimer on behalf of the child and remain on site whilst the child is skiing or snowboarding.
7. Those not adhering to the standards will be asked to leave the slope and will not receive a refund. Any person not understanding the above standards will not be allowed to participate.

TUITION AND INSTRUCTION

8. All persons attending for tuition, instruction or supervised sessions whilst under the guidance of Sunderland Snowsports Centre Instructors must also agree and accept 1 and 2 as noted in this document, and must be willing to accept inherent risks and dangers associated whilst participating in ski or snowboard tuition. If you choose not to sign the disclaimer your lesson will be cancelled and you will not receive a refund other than where the 48hr cancellation rule is applicable, ie:- 48hrs notice must be given to receive a full refund for the session.

SNOW TUBING

9. All persons attending for casual snow tubing sessions must also agree and accept 1 and 2 as noted in this document, and must be willing to accept the inherent risks and dangers associated whilst participating in snow tubing. If you choose not to sign the disclaimer you will not be permitted to take part in the session and the cancellation rule is applicable, ie:- 48 hrs notice must be given to receive a full refund for the session. Please ensure you read and abide by the rules on the handout you will be issued prior to your session ('Tubing Safety Rules'). Snow tubing is for 4 years and above only, an accompanying adult of children under 8 years must sign the disclaimer on behalf of the children.
